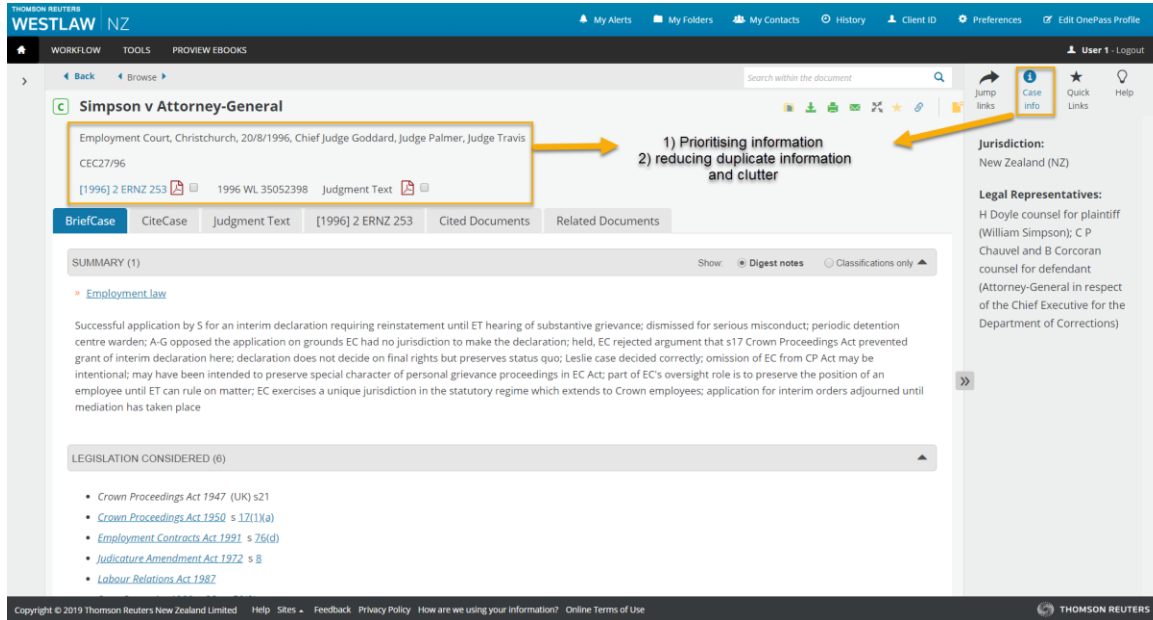


Westlaw March Release Now Live!

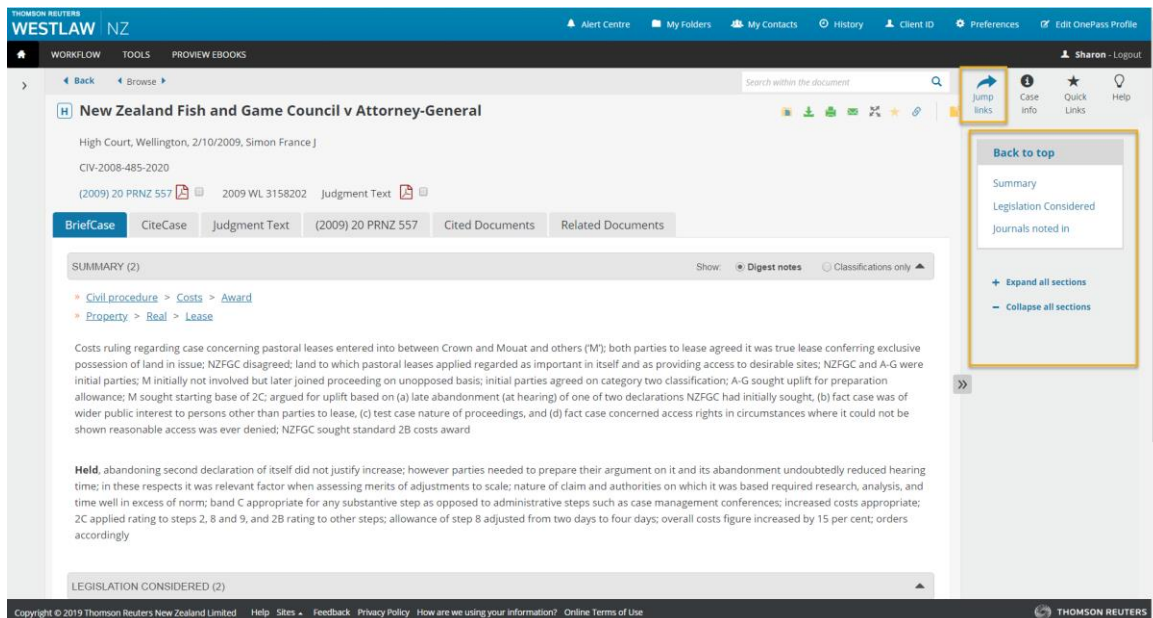
The March 2019 Westlaw NZ release is now live! The release focuses on improving case law research by providing access to case information and creating a seamless flow from cases to other secondary sources.

This release includes but is not limited to the following items:

- 1) The case information will be repositioned to the top of the document page and the right-hand pane.



- 2) We have re-positioned the jump links to the right-hand pane to enable quick access to any parts of the case document pages. They will remain sticky and accessible at all times.



3. We have introduced a new table view for Cases Citing and Cases Cited information to improve readability. This table format includes sorting and filtering options such as Courts, Types of Treatments, Title, Citations, Judgment Date and Citing Count.

*Please note that Courts and Citing Count information displayed in this feature will be progressively completed over the coming months to provide an enriched Cases research experience.
