

Creating a Deep Link into Thomson Reuters Westlaw



Westlaw supports deep linking to most parts of the site.

Links can be created using the **Portal Manager** located in the Tools section of the site. The Portal Manager is only accessible by Known Users, i.e users with a OnePass.

Creating a Deep Link

To create a deep link:

1. Go to the Westlaw home page and click the **Tools** Tab.
2. Click on **Portal Manager**.
3. Select the **Content Links** Tab.
4. Click **Create Content Links Module**
5. Enter a name for your module e.g. Australian Newspapers.
6. Click the **Select Westlaw Content** radio button.
7. Browse to your target landing page or material.
8. Click **Add** to select a landing page or material. *
9. Click **Save Module**.
10. Click **Preview Module**.
11. Right Click on Link and select "Copy Link..."



* Instructions above are for creating a single deep link. However a single module can contain multiple links if required.

Creating a deep link with IP Access

To create an IP Deep Link:

12. Follow steps 1-11 above then add "&SP={INSERT SPONSOR ID}" to the end of the URL.




Creating a List of Deep Links

Creating Multiple Links

To create a list of Deep Links:

1. Go to the Westlaw home page and click the **Tools** Tab.
2. Click on **Portal Manager**.
3. Select the **Content Links** Tab.
4. Click **Create Content Links Module**
5. Enter a name for your module e.g. Australian Newspapers.
6. Click the **Select Westlaw Content** radio button.
7. Browse to your target landing pages or materials.
9. Click **Add** to select each landing page or material.
10. Click **Save Module**.
11. Click **Preview Module**.
12. URL's can be copied from the preview screen individually or all Deep Links can be extracted by clicking **Done** and then **Get HTML**
13. To extract all links click **Get HTML**, then either:
 - Click **Download** for an HTML file of the links.
 - Click **Copy to Clipboard** to copy and insert HTML directly.



Creating multiple links with IP Access

To create multiple IP Deep Links:

14. Follow steps 1-13 above then add "&SP={INSERT SPONSOR ID}" to the end of each URL or in the HTML code.

Links below are generic and can be used for OnePass Username & Password access. If Transparent [IP] Authentication is required then add "&SP={INSERT SPONSOR ID}" to the end of the URL.
