Precedents Drafting Aide User Guide

Thomson Reuters Precedents have a document automation feature called the Precedents Drafting Aide (the Drafting Aide). The Drafting Aide is a Microsoft Word (MS Word) Macro which has been specially created to help you draft and fill in form documents with speed and efficiency.

You only install the Drafting Aide once on your computer and it is available to you every time you use MS Word.





By default, the file will save to the *Downloads* folder. If you click on the dropdown menu next to *Save* you will have the option to *Save as*, to save the file to another location of your choice.



After saving you will get a message:

The Brkprcd4.doc download has completed.



You will be given the option to *Open, Open folder* or *View downloads*. If you wish to install the Drafting Aide now, click on *Open* to open the Drafting Aide installation file in MS Word. 











3. Click on *Add-ins*, then select *Word Add-ins* from the drop-down menu at the bottom of the window and click *Go*



4. Check in the list of *Global templates and add-ins* for the file name *brkprcd.dot*:



If the checkbox next to the file name brkprcd.dot is not ticked, tick it and click OK.

(NB: If the checkbox is not ticked, this causes either:

- the Add-ins tab to not appear; OR
- the Drafting Aide icon not to appear in the Add ins tab)
- 5. Restart MS Word





2. I got to the end of the installation process, but when I restarted MS Word, there was no Addins tab (MS Word 2007 and above)

Follow the instructions as for problem 1 above.

3. When I try to install the Drafting Aide, MS Word hangs/freezes

The Drafting Aide has been tested and successfully installed in all versions of MS Word from MS Word 97 through to MS Word 2016.

If MS Word freezes or hangs during installation, it is possible there is something in your own IT environment that is preventing the Drafting Aide from installing successfully.

You may contact Techcare (0800 10 60 25 or email <u>techcare.anz@thomsonreuters.com</u>) or, your own IT support (if you have any) if you need help to trouble-shoot such problems. (Support is also available directly from Microsoft; see https://support.office.com/).

Some things an IT support person should check would be:


- Was there an email application that was open when the Drafting Aide was being installed?
- Are the latest MS Word updates installed (there may be an issue that has been resolved in a recent update)?
- Are there incompatible Add-ins installed in the copy of MS Word you are using (if so, it may be
 necessary to disable these before installing the Drafting Aide see instructions under 4. below)?
- Are there security settings set up by your IT systems administrator (eg which block you from installing a macro) that might be preventing the Drafting Aide from installing?
- Are there any other software/operating system conflicts causing MS Word to freeze/hang (check if
 any other new software has been installed recently that might be causing conflicts, or; check
 Microsoft support forums for any known conflicts: https://support.office.com/)?


4. I have Infinity Law and I can't install the Precedents Drafting Aide

There is currently a conflict between the Infinity Law, MS Word add-in; and the Precedent's Drafting Aide add-in, which may interfere with installing the Precedents Drafting Aide. This conflict can be worked around by disabling the Infinity Law add-in during the installation process (the Infinity Law add-in will come back automatically the next time MS Word is started):

- 1. Close Word if it is open.
- 2. Open MS Word in "Safe mode" as follows:
 - Press the CTRL key at the same time as double-clicking on the MS Word icon document, or on a MS Word document (which can be any MS Word) document.
 - You should get a message like this



• When MS Word opens in safe mode there should be something at the top of MS Word confirming that it is open in safe more:



- When you have confirmed that MS word is open in safe mode, start the installation process again. Either:
 - o Download the file Brkprcd4.doc again (see Downloading above); or
 - Find the file Brkprcd4.doc in your Download folder and double click on it to open MS Word.
- Follow the instructions for installing the Drafting Aide (see <u>Installing</u> above).
- After installing restart Word and the drafting aide should be in the add-ins tab and work
 perfectly! (assuming there is nothing else other than Infinity Law interfering with the process).

5. Can I install the Drafting Aide on an Apple computer?

While *Thomson Reuters Precedents* are not compatible with Apple computers, if the user is running Windows emulation software, both the Precedents and the Precedents Drafting Aide should run as normal inside the emulated Windows environment.


After opening a Precedent, launch the Drafting Aide by clicking on the Drafting Aide icon



You will find the Drafting Aide icon in the *Add-ins* tab (MS Word 2007-2016) or in the Toolbar (MS Word 2003 and below):




When you click on the Drafting Aide icon, the Drafting Aide will open, as below:

Variables

Variables are the bits of information that you fill-in in a form document (such as: [company name], [address], etc); they are called "variables" because they vary each time you fill in the form.


The Drafting Aide will take you through all the variables in a Precedent and allow you to fill in each piece of information one-by-one, without you having to type in the document itself; the Precedents Drafting Aide automatically inserts whatever you have typed or selected into the correct place(s) in the form.

Where a variable occurs several times in a document – for example, [respondent's name] – you only need to type that variable once in the Drafting Aide and it will be copied automatically to all the other places in the document where it appears.

Types of variables


The Thomson Reuters Precedents documents contain the following types of variables:

1. A request to fill in certain **information**, for example:





2. A **choice** variable, requiring you to choose which piece of text from a list you wish to insert, for example:





5. A **suboption** (ie, an option that is within another option). For example:






6. A **choice** between two or more sections of the document (these sections can be just a phrase, or several clauses in length), where you can only include one of the alternative selections, for example:





7. A subchoice (ie, a choice within another choice), for example:



The variables appear in blue text in the documents.

Keyboard navigation in the Drafting Aide

- TAB: use the TAB key to navigate your way through the available options on the dialog box.
- ENTER: use the ENTER key to execute the selected button or to insert your typed text.
- **SPACE**: use the SPACE key to execute the selected button.
- **CTRL** + **ENTER**: will create a new line when entering text.
- ARROW keys: use the ARROW keys to navigate between different choices in the variable information box.
- **SHORTCUT** Keys: each button has its own shortcut keys place your mouse over the button to see the keys required or refer to the list below.

Please note: When using Word 2000 the text in the Precedents Drafting Aide may not be automatically highlighted. To overcome this, simply press the TAB key and the text will be automatically highlighted.

Mouse navigation in the Drafting Aide

SINGLE Click: using the left mouse button, a single click will execute the required button or place the cursor in the input box.


Drafting Aide Buttons

Press the *Ctrl* key and click on a button below to jump to the explanation for that button:




YES/OK: (ALT + Y)

The OK button will replace the highlighted variable with either your text or your selected option or choice.




NO/DELETE VARIABLE: (ALT + D)

The NO button will remove the highlighted text from the document, including the preceding space if appropriate.




SKIP: (ALT + K)

The SKIP button will skip the highlighted variable and then locate and highlight the next available variable.




BACK: (ALT + J)

The BACK button will allow a user to modify a previously completed variable.




LEAVE BLANK: (ALT + B)

The LEAVE BLANK button will replace the highlighted variable with one of the three available spaces: 2cm, 6cm and 12cm.




STOP: (ALT + S)


The STOP button will close the Precedents Drafting Aide.



Document reformat tools: (ALT + T):



This button will present you with a pop-up box with several options. (This box will also pop up automatically when there are no more variables to fill, or if you exit out of the Drafting Aide).




The available options are:

1. **Import styles from another document** – this will allow user to import formatting styles from another document.

If *Import styles from another document?* Is selected, when you click the play button at the bottom of the dialog box, you will be taken to the *documents folder* to select a document from which you would like styles to be imported.

Browse to the document you would like to use, select that document and then click *Open*. The styles from that document will then be imported into the Precedent (this may take a few moments).



- 2. **Remove editorial notes** this will remove all instances of green italicised editorial notes and any external logos or graphics present in the document.
- 3. **Change all text to normal text** this will change the colour of the blue variable text to black and its style to non-italic.
- 4. **Renumber paragraphs** allows users to renumber paragraphs/subparagraphs automatically after removing or adding paragraphs/subparagraphs.

The renumbering function can work with several different paragraph label formats (and combinations of label formats – ie where several different label formats are used within one document):

- A., B., C.
- 1, 2, 3
- 1.,1.1, 1.11...2., 2.1, 2.11...
- (i), (ii), (iii)
- (a), (b), (c)

Any time you add paragraphs to or remove paragraphs from a *Thomson Reuters Precedent*, if you use the *Renumber Paragraphs?* function, it will go through the document and renumber/resequence all the

paragraph/subparagraph labels that are out of sequence (NB provided any added paragraphs/subparagraphs have the same formatting/styling as other items in the same list).

You may use the renumbering function on a *Thomson Reuters Precedent* on its own, (for example, if you filled in all the variables earlier, but later decide to add new paragraphs/subparagraphs or to remove paragraphs/subparagraph - or both). Just:

- · open the document;
- launch the Drafting Aide;
- click on the Reformatting Tools button;
- select the Renumber Paragraphs? option; and
- click the *play* button.


Cross-references: please note, the renumbering function does not currently resequence cross-references (references within a document to other clauses or paragraphs in the same document) to match renumbered paragraphs. If you use the renumbering function, any cross-references that are affected by the renumbering will need to be updated manually.

Using the renumbering function on documents that are not *Thomson Reuters Precedents*: Please note, the renumbering function may not necessarily work on documents other than *Thomson Reuters***Precedents.** For the renumbering function to work, paragraphs and subparagraphs must be formatted/styled in a particular way. **Thomson Reuters Precedents** are pre-edited so all the paragraphs and subparagraphs are already in the correct style to allow the renumbering function to work.

5. **Save the document** – this will allow you to save the document at the same time as exiting the Drafting Aide.


HELP: (ALT + H)

This button will open the Help information.



TOGGLE SCROLL OPTIONS:

This feature will allow you to toggle between scrolling with the Drafting Aide box (the default) and scrolling through the document (while the Precedents Drafting Aide continues to run).



Clicking on the *dot* toggles between the two *scroll* options.


Moving the Drafting Aide Dialog Box

The Dialog Box may be moved from its current position on the screen by holding down the left mouse button on the dialog box title bar, labelled *Precedents Drafting Aide*, and dragging the dialog box to a new position on the screen.

When all the variables in a Precedent have been filled; or, if the user exits out for the Drafting Aide, the *Document reformat tools* dialog box will open automatically:



These tools may also be accessed within the Drafting Aide by pressing the Document Reformat Button:

Tips/FAQs


1. What if I'm using the Drafting Aide and I find I don't have all the information needed to fill in a Precedent – can I run the Drafting Aide again later on the same document to enter the rest of the information?

You may partially fill in a Precedent and then re-run the Drafting Aide on it to fill in more information later, as many times as you need to.

If you run the Drafting Aide and skip over some variables, the next time you run the Drafting Aide it will take you straight to those variables you did not fill in the last time (it will do this even if previously you changed all the variables from blue to black text using the *Document Reformatting Tools*).

2. I already used the Drafting Aide to fill in all the variables in a Precedent – now I've added/removed some paragraphs and I need to renumber the paragraphs again – can I use the Drafting Aide just to renumber paragraphs?

If you run the Drafting Aide on a document where all the variables are already filled in, the Drafting Aide will take you straight to the *Document Reformatting Tools* dialog box:



If you wish to renumber the paragraphs, just tick *Renumber paragraphs?* and click the *play* button (there is no need to untick the two default options that are already ticked).

Using the Drafting Aide - Trouble-shooting

1. The Drafting Aide is not enabled (Word 2003, Word 2000 and Word 97)

Sometimes Word decides to disable the Precedents Drafting Aide. In Word, click *Help*, *About*, *Disabled Items*. *Disabled Items* may list the Drafting Aide. You can enable the Precedents Drafting Aide by clicking *Enable*.

2. Renumbering has not worked properly

If you use the renumbering function and renumbering does not work as you expected, there may be a bug in the document. Please contact one of the Precedents Editors:
