## Tips for using Search & Summarise

#### How to build a better query

Write a clear, concise, and focussed query that is 1-2 sentences long. Consider adding information, such as practice area, governing law, remedy, desired outcome, or material facts to provide better context for the query.

- Query: What is a temporary worker?
- Better Query: For the purposes of Agency Regulations, how is a temporary worker defined?

Provide relevant facts material to your research but do not include extra background facts that are not material to the question. Each term in a query should be essential to finding relevant information.

- Query: I have a claim currently in progress for a breach of contract. My client wants to
  make a settlement offer (a Part 36 payment) but I need to explain the pros and cons of
  making such a claim to help them make an informed decision.
- Better query: What should be considered when offering a part 36 payment in a claim for breach of contract?

Do not write a query in the style of a prompt, command, or instruction. We have done the prompting and instruction work for you and have designed Search & Summarise to work best with legal research queries that clearly identify the information you would like to find. **For example,** it is better to avoid including extra words or phrases like "find resources that..." that bookend the query but are not substantive. Instead, it is better to construct a query with words or phrases you would expect to find in Practical Law resources.

- Query: You are an experienced attorney who is an expert legal researcher, and you
  need to find, summarise, and present some guidance on what a law firm should put in
  place to avoid facilitating in tax evasion which is an illegal activity.
- Better query: How can I prevent our company facilitate tax evasion?



#### What can't Search & Summarise do?

Search & Summarise does not yet support the following tasks, but we're working on them, and you can expect to see many of them in the future:

- Boolean or fielded queries, e.g. "break clause" /p "service methods"
- Questions about specific documents, e.g. Does the Master Will include a provision on donating to animal charities?
- Requests for analytics, e.g. How many M&A deals in 2023 included automotive companies?
- Commands to execute certain tasks, e.g. Email me the Share Purchase Agreement and any additional clauses that relate to limitation.
- Requests for comprehensive document retrievals, e.g. Find all documents relating to unfair dismissal.
- Instructions to filter resources, e.g. Exclude any non-compete clauses.
- Requests for timing or mathematical calculations, e.g. By which date do I need to file a notice of appeal for a judgment entered on 8th July?
- Questions about predictions of outcomes, e.g. Will the budget include an increase in the income tax rate?
- Requests to draft content, e.g. Can you draft me a non-compete clause?
